


Dear Mark,

### **Retitling Timing and Process**

All titling requests are to be submitted between October 1st-December 15th of each year. This will allow any changes to be completed before the close of the calendar year. Outside of this time, if a change is needed it may incur a processing fee up to \$500.

In order to complete the processing of your title the following items will need to be submitted:

1) A formal request signed from the shareholder stating the current title and number of shares and the new titling and number of shares to be transferred.

\*If the shares are held in a corporation or trust we will need a copy of the documentation showing the signing individual as a signor on the entity.

2) A mailing and email address for the new certificate.

**\*If the client is transferring to a new individual we will need a copy of that person's identification in addition to their email address and mailing address.**

**3) In the case of a death, we will need a copy of the death certificate and probate documentation or will for the original shareholder showing the desire for transfer of ownership.**
