The Defendant filed an answer to our opposition of the Weapon X Motorsports trademark application. I spoke to the Defendant's attorney last week to discuss their defense and claimed priority date. He provided no verifiable facts regarding their first date of use, but told me he would speak with his client and get back to me.

At this point, I expect we will proceed with discovery requests on the issues of priority and corporate dissolution.
