Regulatory Evasion via Justification Loop Jurisdiction: CRA, FINTRAC, Ombudsman, LECA, OSC
Claim Type: Systemic Negligence, Misfeasance, Breach of Duty

I am fully aware of the defamation of character placed against me by my father and other police force agents uttering that I am incapable of caring for myself. I would like your name, your identification, as well as the police officers names and identification who have defamed and slandered me

I will also need the names of each individual who validated that my mail was not stolen, my ID's were not stolen, and that trespassing from someone who has molested me as a child does not need any action.

Action will be taken against LECA, the Local Police Force, and other agencies who have defamed my character, who are involved in the cited frauds with the Rotary Club, and it's religious members being cited as a criminal terrorist organization who have intentionally targeted me.

I will also need the names of each person who has signed off on these requests to investigate mail theft, identity card theft, trespassing, and gang stocking.

LECA obligated to investigate throughoughly and LECAs failure to discuss the matter with me directly implicates LECA and all other relevant agencies in the following. Their failure constitutes regulatory negligence and breach of public trust.

Abuse of process, Charter s.7 (requires all agencies the security of the person), Intent to mislead s.131 , Obstruction of Justice s.139, Accessory After the Fact s.23, Aiding Offense s.22, Civil Breach, Aiding and Abetting, and Organized Crime Collusion.

Every unauthorized action should be paired with a clear record of LECAs non-consent, and reason for non consent.

Cooper v. Hobart and CRA's own mandate to show they owe a duty of care when harm is foreseeable and jurisdictional.

LECA will be cited as stating

"...permit the Complaints Director not to cause a complaint to be investigated if, having regard to all the circumstances, it is not in the public interest to do so." it is not in the Canadian governments interest, acting in collusion with a terrorist organization against it's citizens, so LECA will not investigate mail theft, identity card theft, harassment, gaslighting.

"...states that it is not in the public interest to screen in a complaint that does not, on its face, disclose a breach of the Act or the Code of Conduct." Meaning LECA is uninterested in the safety of its citizens, and instead investigate and remedy only police officer direct misconduct, and on its face LECA does not protect against failure to investigate mail fraud, mail theft, trespassing, or otherwise leaving no avenue for public recourse in systemic gaslighting.

Plaintiff is unable to speak with the Police Station, the Chief of Police, is redirected to LECA when the police fail to act, and LECA only investigates if there is any relevant police misconduct, not if they do not perform their actual duties creating a systematic loop which accomplishes nothing and evades any citizen protections. "Law Enforcement Complaints Agency (LECA) is **responsible for receiving, managing and overseeing public complaints** about misconduct."

INSTITUTIONAL EVASION OF INTERNATIONAL FRAUD AND CRIMINAL COLLUSION

1. *Local Police* - evade mail theft, identification theft, trespassing, slander, gaslight and gang stock.

2. *LECA* - an organization created to deceive public safety and police oversight, essentially aiding and abetting organized crime, Conspiracy to obstruct justice, Misfeasance in public office. **Charter Breach:** Denial of remedy may violate Section 7 (security of the person) and Section 15 (equality).

3. *OPP Police* - non response

4. *RCMP Police* - in regard to greater issue of tax evasion, soliciting illegal shares, targeting, death threats, non response, redacted forms removing guilt party names only, no investigation

5. *Ontario Securities Commission* - No KYC, or AML documentation filed, Caye Bank forging documentation. Corporation who sold securities is not filed in the country they claimed, not filed to sell securities in Canada, and case close indicating unknown financial asset vehicle sales. Misfeasance in Public Office.

6. *Ombudsman* - Deflection of responsibility as outside of their jurisdiction.

7. *CRA* - Uttering Forged Documents, Criminal Collusion, Accessory After the Fact, Aiding and Abetting Organized Crime, of said crimes, reveal systemic patterns of collusion, evading justice through new trust / laws cited in bill C-32. Misfeasance in Public Office. .

The Labyrinth of Justifications — each agency acts as an illusionary node representing the illusion of remedy, where each agency gestures toward action but passes the burden into a void. LECA's silence is not a failure — it is bureaucratic deflection. An echo in an unending chorus of denial even in the face of mass Fraud, Defamation, Slander, Failure to act, which will be brought up.

I do not appreciate the slander your police agents used against me, and am solely responsible for designing the world standard RCS Rocket Thruster Ignition System used AS STANDARD across all aerospace agencies, have several space agencies who are looking to contract me currently, as well as having been contracted for US Government Aerospace Defense Contracts.
