- In addition, shares offered to investors appear to violate securities laws, with misleading documentation and no proper registration.
- International Trust scheme defrauding billions from the middle class citizen and governments around the world. The case investigated revealed undeniable proof of the scheme in Nicaragua. Individuals in Nicaragua have already been arrested, laws re written, and land seized from owners who were attempting to defraud the government.
