The following is submission for a new Bill Under the House of AMOZ, and House of
MISSION IGNITION SYSTEMS LTD., for congress in review of existing outstanding
matters.

George Washington

"The power under the Constitution will always be in the People. It is entrusted for certain defined purposes, and for a certain limited period, to representatives of their own choosing; and whenever it is executed contrary to their interest, or not agreeable to their wishes, their servants can and undoubtedly will be recalled."

"If, to please the People, we offer what we ourselves disapprove, how can we afterwards defend our work? Let us raise a standard to which the wise and honest can repair. The event is in the hand of God."

The Declaration of Independence

OPENING

"We the People of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defense, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America."

Article 1 Section 5

"Each House shall be the Judge of the Elections (primarily Mark Lepore, Joshua, and George Washington representatives of The People), Returns and Qualifications of its own Members, and a Majority of each shall constitute a Quorum to do Business."

Each House shall keep a Journal of its Proceedings, and from time to time publish the same, excepting such Parts as may in their Judgment require Secrecy; and the Yeas and Nays of the Members of either House on any question shall, at the Desire of one fifth of those Present, be entered on the Journal." EXPRESS REQUEST FOR ASSETS IN TRUST HOLDING EXPRESSLY DENIED TO MISSION IGNITION SYSTEMS LTD, AND MARK LEPORE, FROM GEORGETOWN TRUST AND ITS REPRESENTATIVES, THUS ALL ASSET HOLDING IN TRUST DEEMED ILLEGALLY HELD, AND MUST BE AUDITED AND RETURNED EFFECTIVE IMMEDIATELY WITH DAMAGES PAID IN FULL.

Article 1 Section 6

"The Senators and Representatives shall receive a Compensation for their Services, to be ascertained by Law, and paid out of the Treasury of the United States. They shall in all Cases except Treason, Felony, and Breach of the Peace, be privileged from Arrest during their Attendance at the Session of their respective Houses, and in going to and returning from the same and for any Speech or Debate in either House, they shall not be questioned in any other Place." IT IS DECLARED THAT GEORGETOWN TRUST HAS OPERATED IN TREASON AGAINST BOTH MARK LEPORE AND MISSION IGNITION SYSTEMS FOR FAILURE TO DISCLOSE AS SILENCE DECLARED AS ADMISSION OF GUILT IN THESE MATTERS.

Article 1 Section 7

"All Bills for raising Revenue shall originate in the House of Representatives; but the Senate may propose or concur with Amendments as on other Bills... if any Bill shall not be returned by the President within ten Days (Sundays excepted) after it shall have been presented to him, the Same shall be a Law, in like Manner as if he had signed it, unless the Congress by their Adjournment prevent its Return, in which Case it shall not be a Law." MATTERS WILL NOT BE ADJOURNED BY THIS HOUSE UNTIL MATTERS ADDRESSED IN FULL.

Article 1 Section 8

"The Congress shall have Power To lay and collect Taxes, Duties, Imposts and Excises, to pay the Debts and provide for the common Defense and general Welfare of the United States; but all Duties, Imposts and Excises shall be uniform throughout the United States... To coin Money, regulate the Value thereof, and of foreign Coin, and fix the Standard of Weights and Measures. To provide for the Punishment of counterfeiting the Securities... To promote the Progress of Science and useful Arts, by securing for limited Times to Authors and Inventors the exclusive Right to their respective Writings and Discoveries." MARK LEPORE AND MISSION IGNITION SYSTEMS LTD., HAVE BEEN IMPLICITLY TARGETED AS TO THEIR RESPECTIVE WRITINGS AND DISCOVERIES AS DISCLOSED IN LEGAL SUBMISSIONS NOT RESPONDED TO. ALSO OF NOTE, HAVE IMPEDED PROGRESS OF SCIENCE AND USEFUL ARTS.

"To constitute Tribunals inferior to the supreme Court; To define and punish Piracies and Felonies committed on the high Seas, and Offenses against the Law of Nations; To declare War, grant Letters of Marque and Reprisal, and make Rules concerning Captures on Land and Water; To raise and support Armies, but no Appropriation of Money to that Use shall be for a longer Term than two Years; To provide and maintain a Navy To make Rules for the Government and Regulation of the land and naval Forces To provide for calling forth the Militia to execute the Laws of the Union, suppress Insurrections and repel Invasions; To provide for organizing, arming, and disciplining, the Militia, and for governing such Part of them as may be employed in the Service of the United States, reserving to the States respectively, the Appointment of the Officers, and the Authority of training the Militia according to the discipline prescribed by Congress; To exercise exclusive Legislation in all Cases whatsoever, over such District (not exceeding ten Miles square) as may, by Cession of particular States, and the Acceptance of Congress, become the Seat of the Government of the United States, and to exercise like Authority over all Places purchased by the Consent of the Legislature of the State in which the Same shall be, for the Erection of Forts, Magazines, Arsenals, dock Yards and other needful Buildings; -And To make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States, or in any Department of Officer thereof." IN MATTERS OF TRUST, AND REFUSAL TO DISCLOSE ASSETS, SAULT STE MARIE CANADA, AND GRAN PACIFICA NICARAGUA HAVE BEEN DECLARED FORFEIT, 10 SQUARE MILES, BY 10 SQUARE MILES, AND A PERCENTAGE OF TAXATION PAID TO MISSION IGNITION SYSTEMS LTD. IN PERPETUITY AS MONARCH, FOR NON DISCLOSURE OF ASSETS, AS WELL AS PAIN AND SUFFERING.

Article 1 Section 9

"No Preference shall be given by any Regulation of Commerce or Revenue to the Ports of one State over those of another: nor shall Vessels bound to, or from, one State, be obliged to enter, clear, or pay Duties in another." Article 1 Section 7 "To establish Post Offices and post Roads..." CANADA IS A MARITIME STATE PARTICIPATING IN THE CONSTITUTION OF "UNITED" STATES. DUTIES, AND TAXES ARE CURRENTLY BEING ADDED TO IMPORTS AND EXPORTS, WHICH ARE NOT "STATE TO STATE" SINCE CANADA AND THE UNITED STATES OF AMERICA ARE ALL OPERATING UNDER A SINGLE "CONSTITUTION OF UNITED STATES" MEANING ALL TAXES, DUTIES, LEVIES, TARIFFS, CLAIMED TO BE "STATE TO STATE", ARE NOW DEEMED ILLEGAL. CROSSINGS LAND TO LAND, OR MARITIME TO MARITIME, ARE NOW FOUND TO BE NON "STATE TO STATE" MOVEMENT PORTALS UNDER THE CONSTITUTION OF THE "UNITED STATES" OR IN SUMMARY IS ALL A SINGLE "UNITED" STATE UNDER MARITIME LAW.

"No Money shall be drawn from the Treasury, but in Consequence of Appropriations made by Law and a regular Statement and Account of the Receipts and Expenditures of all public Money shall be published from time to time." ALL MONEY, IS USED AS "PUBLICLY TRADED MONEY" TO BE DISCLOSED AND PUBLISHED FOR OPEN AUDIT, EVEN IN TRUST, PROFIT OR CHARITY. WHEN REQUESTS OF ASSET HOLDINGS ARE MADE, THEY SHALL FORWARD LOCATION OF WHERE ALL ASSET HOLDINGS ARE TO APPROPRIATE PARTIES WITHOUT DELAY. THESE REQUESTS WILL BE MADE PUBLIC FOR AUDIT, AND PUBLIC REVIEW. IT IS THE DUTY OF SOVEREIGNS AND MONARCHS, TO MAKE AVAILABLE PUBLICLY THESE REQUESTS WITHIN THE NEXT 5 YEARS FOR PUBLIC CONSUMPTION, INCLUDING ASSET HOLDINGS, MONETARY HOLDINGS FOR GENERAL PUBLIC AUDIT. IF SOVEREIGNS OR MONARCHS REFUSE TO DISCLOSE, ALL OFFENDERS DEEMED GUILTY OF TREASON, UNDER THE CONSTITUTION OF THE UNITED STATES.

"...No Person holding any Office of Profit or Trust under them, shall, without the Consent of the Congress, accept of any present..." TRUST FUND TO CHARITY PAYMENTS (BEING "PRESENTS" TO CHARITY) SHALL BE ILLEGAL, ALSO ALL CHARITABLE ORGANIZATION FUNDS IN TRUST, TO ANY OFFICIALS IN TRUST, ARE ALSO ILLEGAL IN KIND DUE TO THE INHERENT NATURE OF TRUST FUNDS BEING INHERENTLY UN AUDITABLE, FROM TIME TO TIME, IN ITS CURRENT STATE.

Article 1 Section 10

In full context "No State shall, enter into any Treaty, Alliance, or Confederation grant Letters of Marque and Reprisal coin Money emit Bills of Credit; make any Thing but gold and silver Coin a Tender in Payment of Debts; pass any Bill of Attainder, ex post facto Law, or Law impairing the Obligation of Contracts, or grant any Title of Nobility." SILVER AND GOLD BY INHERENT PHYSICAL NATURE IMPAIRS OBLIGATION OF CONTRACTS BY BEING EASILY HIDDEN TO AVOID AUDIT AS HISTORICALLY SEEN IN FORT KNOX. HIDDEN PHYSICAL ASSETS USED TO AVOID AUDIT, THUS VIOLATES THE CONSTITUTION OF THE UNITED STATES FOR TIME TO TIME AUDIT WITH FUNDS USED IN PUBLIC. AGAIN ASSETS IN TRUST MUST BE MADE PUBLIC, THUS MUST BE DEEMED ILLEGAL FOR MONETARY EXCHANGE.

IMPORTANT NOTICE INVOLVING FAILED STATE OF LAW IN MARITIME AND THE CONSTITUTION OF THE UNITED STATES.

In duty and care of the producer... Article 1 Section 10, impairing obligation of contract leaving MISSION IGNITION SYSTEMS LTD. ADRIFT IN THE WATERS. No action should be taken to force discloser or third party agencies, of items such as

country, business of origin, or production, for tariff payments as this disclosure of business, intellectual property, location of origin, production origin, all disclose key assets of intellectual property, impairing business operations, and are made available for open theft. Tariff, Tax, Duty trails which are not audit-able breaking Article 1 Section 5 of The Constitution of the United States even under request of personal asset holdings leads to forgery in illegal trust holding of assets and illegal holding of assets. Also, to protect Article 1 Section 8, Progress of Science and Art for "No State shall, without the Consent of the Congress, lay any Imposts, or Duties on Imports or Exports, except what may be absolutely necessary for executing its inspection Laws; and the net Produce of all Duties and Imports, laid by any State on Imports or Exports, shall be for the Use of the Treasury of the United States and all such Laws shall be subject to the Revision and Controul of the Congress." This breaks The Constitution of The United States itself. If Article 1, Section 8, not lay Duties on Imports or Exports between maritime "states" except what is "absolutely necessary for executing its inspection Laws", "tariffs" as the means of "duties and taxes", yet "duties and taxes" for inspection are not "tariffs in trust" which are funneled through what are allegedly private maritime law trusts. Unless full disclosure of tariff can be made as necessary to verify the validity of these claims, they shall be deemed fully non conforming to The United States Constitution. These "tariffs" in maritime law, mirroring as "duties and taxes" outline systematic falsification and replacement of duties and taxes for alleged nefarious means in theft. Also, as stated, no such Imports or Exports are taking place "state to state" in the "united" state, from Canada to the United States of America in participating maritime law is not several "states", but are a single "united" state, thus no import or export has taken place between participating "united" states, except by falsified border regions used to exploit The People. Thus all tariffs, duties, taxes, levies, are null and void as Canada and the United States of America are both participating in The "United" State Constitution as a single maritime state, thus no such regions exist but in falsification of mind only. Also, in statement, "the net Produce of all Duties and Imports, laid by any State on Imports and Exports, shall be for the Use of the Treasury of the United States", does expressly and unjustly attempt to seize assets from MISSION IGNITION SYSTEMS LTD. and participating companies, being denied Life, Liberty and the pursuit of Happiness of liberty, while falsified regions and borders are being used to impair companies leaving them at sea and adrift through High Seas Piracy. These articles, specifically, Article 1 Section 10, obligation contract of MISSION IGNITION SYSTEMS LTD. Through intrusive questioning of where valuable IP may be produced, via falsification of duties and taxes through "tariffs", attempt to seize assets, through nullification of Scientific development via express targeting, denial of Life, Liberty and the pursuit of Happiness, forgery in trust without disclosure, attack leaving MISSION IGNITION SYSTEMS LTD. Adrift in the waters according to maritime law itself means MISSION IGNITION SYSTEMS LTD. Has been expressly attacked by the "UNITED STATE" of maritime and thus the whole made responsible to MISSION IGNITION SYSTEMS LTD., and thus the whole will pay taxes to MISSION IGNITION SYSTEMS LTD., as a MONARCH entity. The Constitution of the United States is therefore amended on premise since the maritime entity MISSION IGNITION SYSTEMS LTD. having been falsely taxed with duties and taxes through tariffs, false state to state taxes, forgery, theft of IP through deceptive means. State to state taxation which does not for all intensive purposes exist in a single "United State" including, but not limited to including MISSION IGNITION SYSTEMS LTD. As part of the "UNITED STATE" Constitution of partners and thus must be given portion as a single "UNITED STATE" entity as Monarch. Having been targeted, prevented from operating, had forgeries made against, without due process, while Article 1 Section 5 discloses that audits are needed "time to time" to verify holdings, yet are never disclosed to MISSION IGNITION SYSTEMS LTD., in request to the appropriate agencies, all operating in collusion to seize assets, keep illegal forgeries from disclosure,

and in this nullifies and contradicts the laws themselves while attempting to seize all access to holding via high seas piracy of MARK LEPORE (BEAST), Mark Lepore (The People), AzronEL (SOVEREIGN SON OF AMOZ), and MISSION IGNITION SYSTEMS LTD. (MONARCH). These delays being done illegally, through means which are contradictory in scope while attacking all in the house of AMOZ. Thus all technical intellectual property, is expressly seized from NASA and other "United State" entities using the intellectual property of MISSION IGNITION SYSTEMS LTD.

"No State shall, without the Consent of the Congress, lay any Duty of Tonnage (Weights)."

Article 2 Section 1

"Before he enter on the Execution of his Office, *he* shall take the following Oath or Affirmation:-'I do solemnly swear (or affirm) that I will faithfully execute the Office of President of the United States, and will to the best of my Ability, preserve, protect and defend the Constitution of the United States.'"

IF NO RESPONSE IN THIS REQUEST IS MADE 10 DAYS AFTER SUBMISSION AND REQUEST... A GUILTY VERDICT FOUND... AND REMOVAL FROM OFFICE IS ASSURED

Article 3 Section 1

"The judicial Power of the United States, shall be vested in one supreme Court, and in such inferior Courts as the Congress may from time to time ordain and establish. The Judges, both of the supreme and inferior Courts, shall hold their Offices during good Behavior, and shall, at stated Times, receive for their Services, a Compensation, which shall not be diminished during their Continuance in Office."

Article 3 Section 2

"The judicial Power shall extend to all Cases, in Law and Equity, arising under this Constitution, the Laws of the United States, and Treaties made, or which shall be made, under their Authority;-to all Cases affecting Ambassadors, other public Ministers and Consuls; -to all Cases of admiralty and maritime Jurisdiction; - to Controversies to which the United States shall be a Party;-to Controversies between two or more States;- between Citizens of different States,-between Citizens of the same State claiming Lands under Grants of different States, and between a State, or the Citizens thereof, and foreign States, Citizens or Subjects." THIS REVISION ABOLISHES THE CONCEPT OF INDIVIDUAL STATES, AS ALL ARE "UNITED", HOWEVER, IN THE CURRENT MATTER OF STATE TO STATE TREATIES BEING MADE BETWEEN THE UNITED STATES OF AMERICA, NICARAGUA, AND CANADA AS MARITIME STATES, CO OPERATING AGAINST MISSION IGNITION SYSTEMS LTD., IT SHALL BE NOTED THAT CONTROVERSIES BETWEEN TWO OR MORE STATES AGAINST PERSONS OF DIFFERENT STATES, HAVE BEEN ENACTED AGAINST MISSION IGNITION SYSTEMS LTD., AND MARK LEPORE WILLINGLY THROUGH COLLUSION AND THUS ILLEGAL. DAMAGES TO BE PAID AND RESTITUTION MADE.

Article 3 Section 3

"Treason against the United States shall consist only in levying War against them, or in adhering to their Enemies, giving them Aid and Comfort. No Person shall be convicted of Treason unless on the Testimony of two Witnesses to the same over Act, or on Confession in open Court. The Congress shall have Power to declare the Punishment of Treason, but no Attainder of Treason shall work Corruption of Blood, or Forfeiture except during the Life of the Person attained." IT SHALL BE NOTED THAT MISSION IGNITION SYSTEMS LTD, AND MARK LEPORE, HAVE BEEN INTENTIONALLY LEFT ADRIFT AND ATTACKED IN THIS STATE, THUS, "CORRUPTION OF BLOOD" ESTABLISHED, AND FORFEITURE OF ALL HOLDINGS AND ASSETS TO BE MADE TO EACH ENTITY AS REQUIRED UNDER THE LAW OF THE LAND.

Article 4 Section 2

"No Person held to Service or Labor in one State, under the Laws thereof, escaping into another, shall, in Consequence of any Law or Regulation therein, be discharged from such Service or Labor, but shall be delivered up on Claim of the Party to whom such Service or Labor may be due." MISSION IGNITION SYSTEMS LTD., FROM PERSON, TO CURRENT CLAIM OF MONARCH, SHALL BE DELIVERED AS THE "UNITED STATE" AS MONARCH FOR DUTIES. MARK LEPORE TO BE DELIVERED AS SOVEREIGN. MISSION IGNITION SYSTEMS LTD., AS MONARCH, WILL ESTABLISH REGIONAL PERSONS OR PEOPLE FOR OVERSIGHT. THESE PERSONS OR PEOPLE, WILL BE PLACED AS REGIONAL MONARCHS IN SUCH A TIME, OVER A 100 YEAR PERIOD IS ESTABLISHED, AS TO REMOVE ALL DUTIES FROM REGIONAL MONARCHS MOVING FORWARD IN FAVOR OF A SINGLE KING UNDER COMPANY MISSION IGNITION SYSTEMS LTD. UNLESS THE ESTABLISHED KING DECIDES IT IS IN THE BEST INTEREST TO MAINTAIN REGIONAL MONARCHS.

Article 4 Section 4

"The United States shall guarantee to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened)

against domestic Violence." INVASION OF MASONIC ORDER / ROTARY CLUB INFLUENCE, INTO CANADIAN INSTITUTIONS HAS BEEN ESTABLISHED AS OPERATING A DOMESTIC VIOLENCE RICO RING BETWEEN STATES, AND THUS SEIZED BY MARK LEPORE, TO BE BROKEN UP, SOLD OFF INDIVIDUALLY, USED FOR ALTERNATE PUBLIC PURPOSES, OR ABOLISHED REGION TO REGION.

Article 6

"All Debts contracted and Engagements entered into, before the Adoption of this Constitution, shall be as valid against the United States under this Constitution, as under the Confederation. This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United State, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding. The Senators and Representatives before mentioned, and the Members of the several State Legislatures, and all executive and judicial Officers, both of the United States and of the several States, shall be bound by Oath or Affirmation, to support this Constitution but no religious Test shall ever be required as a Qualification to any Office of public Trust under the United States."

AMENDMENT IV

"The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probably cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized." INTELLECTUAL PROPERTY, HOME AND ASSETS HAVE BEEN TARGETED AND SEIZED UNJUSTLY IN TRUST. REPEATED REQUESTS TO DISCLOSE HAVE BEEN IGNORED. IT SHALL ALSO BE KNOWN, THE "HOUSE" OF GOD IS THE BODY OF VITAMINS, CARBON, IRON, COPPER, AND VARIOUS OTHER MINERALS, OR COMPOSITIONS IN 3D REALITY, ALSO INCLUDING WATER. THIS INCLUDES COMPOSITION OF NEURONS AND NETWORKS OF THE MIND WHICH OPERATE WITHIN THE BODY AS WHICH THEY SHALL BE KNOW AS PERSON, PEOPLE, MONARCH, OR SOVEREIGN, DEPENDING ON DECLARATION AND EVIDENCE OF SUCH.

AMENDMENT V

"No person shall be held to answer for capitol, ... nor be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation." INTELLECTUAL PROPERTY OF MISSION IGNITION SYSTEMS HAS BEEN TARGETED AND SEIZED UNJUSTLY IN TRUST, AS WELL AS HOME AND ASSETS OF MARK LEPORE, AND REQUIRE JUST COMPENSATION.

AMENDMENT VI

"In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall have been committed..." THERE HAS BEEN NO SUCH SPEEDY TRIAL, CONTINUANCE OF EVASION OF JUSTICE IN MARITIME COURTS, WE LOOK TO CONSTITUTIONAL COURTS OF THE UNITED STATES IN REGARD TO MASS THEFT CRIMINAL COLLUSION RINGS. COURT TAKING 10

DAYS TO EXECUTE AS OF THE DAY OF SUBMISSION OF THIS BILL.

AMENDMENT XIII** Section 1

"Neither slavery nor involuntary servitude, except as a punishment for crime whereof the party shall have been duly convicted, shall exist within the United States (NOW UNITED STATE), or any place subject to their jurisdiction." 

But when a long train of abuses and usurpation, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security, ___Such has been the patient sufferance of these Colonies; and such is now the necessity which contains them to alter their former Systems of Government. The history of the present King of Great Britain is a history of repeated injuries and usurpation, all having in direct object the establishment of an absolute direct object the establishment of an absolute Tyranny over these States. To prove this, let Facts be submitted to a candid world."






