When I was suppose to sign for the paperwork on my home in Gran Pacifica, which was paid in full, Mike Cobb was there to do a walk through with me, in which he has never done with anyone else. Upon reflection of what someone said to me, Mike Cobb was carrying around a binder with ALL my information, all our emails, which was FULL of our corespondance and my personal information. I believe even at the outset I was implicitly targeted by their organization and that the Rotary Club influence extends much beyond the Nicaraguan borders. Who is carrying around a binder FULL of a customers information, all emails since the beginning?

God also revealed evidence of Grant Montgomery, an ECI Development employee, whos wife Sasha Montgomery who works on the Gran Pacifica Master Association advisory comittee, attempting to defraud me out of \$1000 USD.

Grant operates a company called Roaming Desk while working for ECI Development. I now believe the two companies are linked. Grant agreed with me that he would design a home for me for lot MV-05 which I purchased separate from EVA 7. Total cost for the purchase was to be \$8000USD, and upon reflection, it was agreed in person with Lorenzo and I that this would be engineering included.

The reason for the land purchase and wanting to purchase MV05 was because I had heard the land was clear title from Lorenzo, and that building there would mean everything is titled properly. I had done this in anticipation of selling EVA7 because of all the titling problems from the outset.

Lorenzo (who is very close with Valeria Espinoza, and who I now believe is part of the scheme with the entire community) also connected me to a builder in Gran Pacifica, Noel Quintara, who I agreed to build the home for me. He asked for \$1000 for the engineering of the home (which should have been provided by Grant as per our agreement). Lorenzo, I now believe now is a wanted criminal on the run from the US government. Name Bjorn, unsure of last name. (I will be reporting to RCMP but suspiciously the "report online" link is now missing for Ontario residents to the RCMP, along with FINTRAC reporting where you need to be an institution to do an online report, which raises more "rotary club connection" speculations and trying to silence me).

In any case, to continue, upon review of Noels agreement to build the planned home, the paperwork said no electrical, no plumbing, no windows, no countertops, in spanish, which I needed to translate, but what was promised to me was a complete home. He requoted with the same price, but everything included and and once I seen this, raised a massive red flag. Noel was paid for a land survey and for preliminary engineered drawings by me.

I wanted to pull up a conversation with Noel, the home builder, because I was going to report this scam of him trying to build the home in collusion with Gran Pacifica, which was essentially an empty shell, but had forgot Noels last name. I had the engineered drawings so thought I would look at the engineered drawings title block for his name... and what I found was that the engineered drawings are from Roaming Desk... Grant Montgomerys company. What was suppose to be Noels work, was Grants work for my house, and yet they were working in collusion to steal \$1000 from me.

What it seems is that they planned to sell me a shell of a house, and to make me pay for everything else, and to leave in frustration. This reminds me of an empty structure in Gran Pacifica called "The Grey Ghost", which is a large building, built and is just walls with no windows, no plubling, and no electricity. This points towards ECI

Development scamming customers, and even other large corporations, in collusion with employees, and residents part of a larger cult organization, to gouge as much as possible from targeted individuals.

Also, upon review of this paperwork, I completely forgot that I have paid Gran Pacifica Master Association money to review the home design Grant made (funny as their employee designed the house). This "formal review process" meant profit for Gran Pacifica Master Association, and Gran Pacifica, which never was posted or shown in the financials to the Nicaraguan government. This also allows ECI Development to evade USA Security laws.

This agreement, also claims that in order to build the home in Gran Pacifica, I had to pay another 1 - 2% of the home value to Villa De Carmen, payable to ECI Development, which they claim was for the local Nicaraguan Municipality. This I am almost certain are more deceptive practices to siphon money from unsuspecting individuals.
